



Commission Staff Technical Amendments
for S.F. 810 (Pogemiller)

The following amendments were prepared by the Commission staff attempting to improve the clarity and language usage of the proposed legislation without changing the substance of the proposed legislation:

LCPR01-81 amends Article 1, the PERA-General membership eligibility revisions.

LCPR01-82 amends Article 2, the PERA-General service credit proration article.

LCPR01-83 amends Article 3, the PERA-General contribution increase article.

LCPR01-85 amends Article 4, the reduction in the PERA-General deferred annuity augmentation rate and the increase in the PERA-General vesting requirement.

LCPR01-86 amends Article 5, the additional PERA-General state aid.

8 business year must be used to determine whether or not a
9 position may be excluded as seasonal when there is less than a
10 30-day break between one seasonal position and a subsequent
11 seasonal position for employment with the same governmental
12 employer. Seasonal positions include, but are not limited to,
13 coaching athletic activities; employment to plow snow or to
14 maintain roads or parks, or to operate skating rinks, ski
15 lodges, golf courses, or swimming pools.
