

1.1 moves to amend S.F. No.; H.F. No., document LCPR10-018,
1.2 as follows:

1.3 Delete everything after the enacting clause and insert:

1.4 "Section 1. **TEACHERS RETIREMENT ASSOCIATION; PURCHASE OF**
1.5 **SERVICE AND SALARY CREDIT FOR DISABILITY PERIOD BY PRIOR**
1.6 **PRINCIPAL OF RED LAKE SENIOR HIGH SCHOOL.**

1.7 (a) An eligible person described in paragraph (b) is authorized to purchase allowable
1.8 service and salary credit in the Teachers Retirement Association for the periods specified
1.9 in paragraph (c), despite receiving Teachers Retirement Association disability benefits
1.10 during the applicable periods.

1.11 (b) An eligible person is a person who:

1.12 (1) is an active Teachers Retirement Association member;

1.13 (2) was the principal at Red Lake Senior High School on March 21, 2005, when
1.14 several murders occurred at the high school;

1.15 (3) suffered a heart attack a few weeks after March 21, 2005;

1.16 (4) was on a Teachers Retirement Association medical leave from February 3, 2006,
1.17 to June 2, 2006;

1.18 (5) commenced receipt of Teachers Retirement Association disability benefits in
1.19 June 2006; and

1.20 (6) later returned to full-time employment with the school district as the principal
1.21 at an alternative learning center.

1.22 (c) An eligible person is authorized to purchase service and salary credit for the
1.23 2006-2007 school year during which the person received Teachers Retirement Association
1.24 disability benefits. An eligible person is also authorized to purchase additional salary
1.25 credit for the 2007-2008 school year during which the person received Teachers
1.26 Retirement Association disability benefits while also providing part-time employment to
1.27 the school district. Following the purchase, the maximum salary credit for either school
1.28 year must not exceed the salary used for purposes of computing contributions under the
1.29 medical leave referred to in paragraph (b). Nothing in this section should be interpreted as
1.30 permitting more than one year of service credit for a given school year.

1.31 (d) Minnesota Statutes, section 356.551, applies to the purchases authorized in this
1.32 section, except as otherwise specified in this section.

1.33 (e) An eligible person shall provide to the executive director of the Teachers
1.34 Retirement Association any relevant documentation that the executive director requests to
1.35 ensure proper application of this section.

2.1 (f) An eligible person who purchases service or salary credit under this section
2.2 is prohibited from entering into a return-to-work agreement under Minnesota Statutes,
2.3 section 354.444.

2.4 (g) Authority to have make a purchase under this section expires September 1, 2010.

2.5 **EFFECTIVE DATE.** This section is effective the day following final enactment."

2.6 Amend the title accordingly
