1.9 Subd. 3. **Reallocation of amortization or supplementary amortization state**

1.10 **aid.** (a) Seventy percent of the difference between \$5,720,000 and the current year
1.11 amortization aid and supplemental amortization aid distributed under subdivisions 1
1.12 and 1a that is not distributed for any reason to a municipality for use by a local police
1.13 or salaried fire relief association must be distributed by the commissioner of revenue
1.14 according to this paragraph. The commissioner shall distribute 50 percent of the amounts
1.15 derived under this paragraph to the Teachers Retirement Association, ten percent to the
1.16 Duluth Teachers Retirement Fund Association, and 40 percent to the St. Paul Teachers

2.22 **Sec. 8. LOCAL RETIREMENT FUND INVESTMENT AUTHORITIES STUDY.**

2.23 A study group consisting of representatives from pension plans subject to Minnesota
 2.24 Statutes, section 356A.06, subdivision 6 or 7, shall be convened by the State Auditor to
 2.25 study investment-related provisions, authorities, and limitations under Minnesota Statutes,
 2.26 chapter 356A, and related sections of other chapters. Administrative support for the study
 2.27 group shall be provided by the State Auditor. The study group shall prepare a report to
 2.28 include an assessment of the effectiveness of current statutory prescriptions, options for
 2.29 change, and recommendations for consideration by the governor and the legislature during
 2.30 the 2011 legislative session. The report will be provided no later than January 15, 2011, to
 2.31 the executive director of the Legislative Commission on Pensions and Retirement, the
 2.32 chair of the Senate State and Local Government Operations and Oversight Committee,
 2.33 and the Chair of the House State and Local Government Operations Reform, Technology
 2.34 and Elections Committee.
