MEMO (Blair Testin) Supplemental Pension Plans. Memo was read and discussed.

Rep. Helen McMillan moved that this subject be referred to the main Commission for recommendation and action. CARRIED.

COUNCIL 6 PROPOSALS Mr. Joe Robison

Local people request a retirement program to allow state employees who work with people in correctional institutions to retire ` at age 50 without reduction in annuity if he has 20 years service.

[10 correctional officers have died in the last 14 months (24 to 65 years of age). A lot of strain on these people].

350 to 400 people involved. These figures need to be compared with the overall statistics of deaths. Mr. Robison will furnish these figures.

The State Capitol employees have made the same request. Will have to find out the cost.

Adolf Erickson problem - Wants an adjustment for the years before 1957. Memo (Moulton) <u>Requests for Increases in MSRS Benefits Attributable to</u> Service Before 7/1/57.

Rep. Helen McMillan moved that this problem be referred to the full Commission  $$\mathcal{C}\-ARRIED$$ 

<u>MSRS HOUSEKEEPING AMENDMENTS</u> - Paul Groschen Copies of amendments furnished the subcommittee.

Amendment No. 1 (32) Staff directed to do research on area wide commissions and their pension coverage - dig out the specific statutes - determine how feasible it is to coordinate pension coverage. Report back to the subcommittee before referring to the main commission. Frank Frison - Council 6 - Advised that he would like to check on the current insurance practices.

Staff will go over housekeeping bill with Mr. Groschen. It will be taken up again in the subcommittee. [Mr. Groschen mentioned 1-16/100 as the cost of .....]
