1. H.F. 2829 (McCauley) - Goodview Firemen's Relief Assn.  
Providing that years of service with the Goodview volunteer fire department shall be treated as years of service with the Goodview firemen's relief assn. Lump sum, \$50 per year of service, to firemen who have fewer than 10 years service.

Providing that years of service with the Backus volunteer fire department shall be treated as years of service with the Backus firemen's relief assn.
