Patrice Beckham and William Hogan, Milliman, Inc., presented the results of the review of the July 1, 2009, actuarial valuation reports and responded to questions from members.

## S.F. 2644 (Betzold); H.F. 2922 (Thissen): Administrative consolidation of MERF into PERA

Lawrence Martin, Executive Director, Legislative Commission on Pensions and Retirement, reviewed the staff memo and policy issues raised by the bill. Mr. Martin reviewed amendment S2644-2A, indicating that on line 1.2, "July 29" should be "June 29."

Rep. Thissen moved amendment S2644-2A, amended on page 1, line 2, delete "July" and insert "June". **MOTION PREVAILED**.

Rep. Thissen moved amendment S2644-3A. MOTION PREVAILED.

Luther Thompson, Assistant Executive Director, MERF, testified in support of the bill and provided handout materials.

Leslie Thompson, Gabriel Roeder Smith, MERF consulting actuary, reviewed the matrix handout.

Mary Vanek, Executive Director, PERA, testified that the PERA Board remains opposed to assuming any of the MERF liability. Ms. Vanek indicated that PERA is concerned that the state funding provided in the bill will continue and not be removed by future legislative action.

Jim Grathwol, Minneapolis Public Schools, testified in support of the bill.

Barbara Johnson, President, Minneapolis City Council, testified in support of the bill.

Jerry Wilson, MERF retiree, testified in support of the bill.

David Johnson, attorney representing the Minneapolis Municipal Retirement Association, testified in support of the bill.

Rep. Nelson moved amendment S2644-1A. MOTION PREVAILED.

Rep. Thissen moved S.F. 2644/H.F. 2922, as amended, be recommended to pass and be included in the omnibus pension bill. **MOTION PREVAILED**.

Division was requested. Upon division, MOTION PREVAILED.

Sen. Lynch moved S.F. 2644/H.F. 2922, as amended, be recommended to pass and be forwarded to the Senate Committee on State and Local Government Operations and Oversight and to the House Committee on State and Local Governmental Operations Reform, Technology and Elections. **MOTION PREVAILED**.

Mary Vanek, Executive Director, PERA, testified in opposition to the bill.

Rep. Thissen moved amendment LCPR09-062-2A.
